Purchase Order #6416, to W.V. Uniform & Equipment, in the amount out \$164.85, for the Correctional Center.


Purchase Order #6414, to H & I Wholesale, in the amount of \$152.47, for the Correctional Center.

Purchase Order #6419, to R. D. Wilson & Sons, in the amount of \$237.79, for the Correctional Center.




