
Upon advertisement to bid for five Sheriff's Department cruisers and two sets of blue lights the following bids were received:





The fee to be charged is \$1,059.50 and are for the following items:


- A. Purchase and use of the PAQ materials for up to 140 full-time employees

- C. Preparation of a summary report including a verbal interpretation of same for the County Commissioners


