Representatives from various county agencies met with the Commission in a meeting regarding the budget. Agencies represented (list of those in attendance attached) spoke positively of the County Commission's efforts, past and present, to obtain funding for them and realize they are now in a "bite the bullet" phase of operation, but will stand behind the Commission in any decision that has to be made.

Bob Scalf of the City of Parkersburg, Councilmen Larry Godfrey and Ben Stump, and Terry Tamburini, MOVRC, met with the Commission to discuss the water problem at Jug Run. It was explained to the Commission that the population of that area has grown and the present water system is incapable of handling the extra load. Terry Tamburini said that he and Joe Carrico, Community Planning, will work on an application for state funding (a community development block grant) which will help supply money for several projects the Jug Run water system being one. Terry and Joe will contact the Commission at a later date with more information.
