This day Commission President, William C. Parrish, signed a letter of assurance for the Director of the Office of Revenue Sharing that the Wood County Government will comply with the requirements of the Revenue Sharing Act 31 U.S.C. 6701-6724. Copy of Order attached.

President Parrish received a call from Terry Tamburini, Director of Mid-Ohio Valley Regional Council, regarding his conversation with Tom Engle, Treasury Department. Mr. Tamburini reported that final figures on revenue sharing will not be released for at least one week, but that they are in the computer. He does not foresee a delay in the arrival of the first check (January 9, 1984).

Harry Deitzler, Prosecuting Attorney, presented to the Commission an amendment to bidding procedures giving preference to in-state bidders. The Commission will make final decision next Thursday.

Bill Pfalzgraf came before the Commission with a petition for the Wood County Development Authority to exercise eminent domain to acquire property near Memorial Toll Bridge. Mr. Pfalzgraf explained that several technicalities had arisen and, although the parties were willing to sell the property, this course was the easiest to obtain the title. The owners and their lawyer were in agreement. Commissioner made a motion to accept the petition, Commissioner Buckley seconded, and President Parrish made the decision unanimous. Copy of Order is on file in Probate.

Pat Minnite, Courthouse Construction Manager, presented to Commission President Parrish, a contract for his signature awarding to Partitions, Inc., in the amount of \$14,800, for installation of  $\frac{1}{2}$ " thick drywall on third and fourth floors of Courthouse. Copy of Order attached.
