At 10:02 a.m. the Commission met with Mr. Rick Brewer from Garrison Brewer Office Supply located in Marietta, Ohio. The purpose of Mr. Brewer's meeting with the Commission was introduce the company to the Commission. Mr. Brewer pointed out to the Commission that their company pay's B & O (Business & Operators) Tax in the State of West Virginia.
