IN RE: Minutes of the Meeting held July 12, 1983

On this day came Robert Morgan and members of the Wood County Rural Association to protest the county's participation in the National Flood Plain Insurance Program. The Association expressed a fear of "back-door" zoning to which this program could lead.

At 10 a.m. Virginia Farmer of the Crime, Delinquency, & Corrections Board brought to the Commission a request to pay from the Board's budget from revenue sharing \$78 for health insurance and \$27 expenses for Warren Stedman the new Program Coordinator.

It was the unanimous decision of this Commission that sheriff's law enforcement cruisers #4, 5, & 6 be taken out of service at this time. Car 4 will be given to Mountwood Park to use as a security vehicle within the park.






IN RE: ASSIGNMENT OF CRUISER CAR #4 TO MOUNTWOOD PARK


