IN RE: Minutes of the Meeting held July 19, 1983

On this day the Commission received two additional requests for revenue sharing from Karen Leachman, Executive Director, Senior Citizens, for \$5000.00; and a request for \$1300 from Vienna Public Library. Members of Blennerhassett & PMBS Volunteer Fire Departments attended the public hearing to reinforce their earlier requests of \$10,000 and \$8,000, respectively.

At 3:00 p.m. the Commission met with Fred Fields, Larry Allen, and Sam Beverage in regard to Godbey Field Project. Sam reported that the Department of Highways has cleaned out a channel and that an adequate grade has been obtained. A letter was sent to Bob Scalf, Public Works Director, City of Parkersburg, stating that the City needs to complete the ditching of the field site and stabilize the dirt fill area.

The Commission witnessed the swearing in of Bruce J. Broberg to Denny Huggins' unexpired term on the Parks & Recreation Commission.






