IN RE: Minutes of the Meeting July 26, 1983

Present: President Pro Tem, Dexter L. Buckley, Jr.
Commissioner, Holmes R. Shaver

Today the Commission allocated \$21,787 in revenue sharing from Entitlement 14. Those receiving funds were: Wood County Senior Citizens, \$4,000 matching with state grant to fix air conditioning; Deputy Sheriffs' Association \$3,400 for communications dish to eliminate dead spots and improve communications; Country Roads Travel Council, \$2,100 for three roadside booths; Blennerhassett Volunteer Fire Dept. \$7,147 for equipment for new boat; PMBS Volunteer Fire Department \$5,140 for payment on new truck.

John Robertson was sworn in on the Wood County Building Commission for a second five-year term.

The Commission received word from the Sheriff's Tax Department that the unencumbered balance for 1982/83 was in the amount of \$65,061.84.






