


Also on this day Emily Bradley was sworn in as a member of the Crime, Delinquency, & Correction Board.



Upon the application of Carney, Dave & Patricia L, who is aggrieved by an erroneous assessment upon real estate in State District, in the County of Wood, for the year 1982, the attorney for the State being present and accepting due and sufficient notice of the filing of this application and defending the same as required by law; and it appearing to the court that this application is made within less than one year after the Commissioner's real estate book for said year was certified.

It is ordered by the court that the said real estate be exonerated from payment.

And the Court doth certify the following as the fact upon which it grants said relief; That said property being 2.44 - A Interstate 77 + R/W, Cl 3, value 26,300 tax 350.42 per half-year. The error occurs in that the property is not rental but used as a residence by Mr. Carney. Therefore the the second half tax should be estimated.

All of which is ordered to be certified to the Auditor of the State and the Sheriff of the County.
