At 9:30 a.m. the Commission met with Mr. Fred Fields from the Soil Conservation Service. The purpose of Mr. Fields meeting with the Commission was to give them an update on the 4-H Drainage Project as well as requeste the Commission's endorsement on a Supplement to the Project Measure Plan as it pertains to the drainage project.

At 10:15 a.m. the Commission met with Mr. Ben McDay Juvenile Service Specialist. The purpose of Mr. McDay's meeting with the Commission was to discuss a contract agreement by and between the Wood County Court and the Department of Welfare. Mr. McDay questioned the validity of the contract due to the fact that when the contract agreement was entered into the Commission was referred to as the Wood County Court instead of the Wood County Commission.

At 10:32 a.m. the Commission met with representatives of the Wood County Deputy Sheriff's Association. Spokesman for the group was Sgt. Rick Woodyard. Sgt. Woodyard pointed out that the Sheriff's Department was grossly understaffed. Sgt. Woodyard went on to say that there were presently 570 warrants on file and that there wasn't enough man power available to deliver them, Sgt. Marshall pointed out to the Commission that there had been several occassions when both the Sheriff and Chief had been contacted for assistance but that they were told to call someone else. Sgt. Marshall went on to say that they called men out to work but that they really did not have the authority to do this. Commission President, William Parrish stated that he didn't understand why the Sheriff was not available for help and assistance when that was his job. The Commission told the Deputies that they would review the matter and talk with the Sheriff to see what could be done.
