IN RE: Minutes of the Meeting held March 29, 1983

At 10:00 a.m. the Commission met with Mr. Bob Morgan, Mr. Ralph Cross, and Mr. Conrad. The purpose of the meeting with the Commission was to discuss the possibility of having the Prosecuting Attorney, Harry G. Deitzler handle legal matters for the Board of Education. Commission President, William Parrish stated that the Prosecuting Attorney's office at present was understaffed and that several cases were backed up due to being understaffed.

At 10:00 a.m. the Commission witnessed an Incompetency Hearing alleging the competency of Gene W. Hisgan. The Commission upon hearing the testimony from the witness and having present before them a copy of the physicians report found the said Gene W. Hisgan to be Incompetent. Now considering the petition of Committee for said Gene W. Hisgan, the Commission believing it proper to do so and due to the fact that no one else was present to wishing to be considered unanimously agreed to accept the appointment of the Incompetent's wife (Evelyn Hisgan) as committee for her husband, subject to the posting of a \$15,000 property bond.

The Commission also accepted and approved a Project Agreement and Operation and Maintenance Agreement by and between the Wood County Commission and the Soil Conservation Service as it relates to the 4-H Wood Co. Fair Drainage Project.

At 2:00 p.m. the Commission met to witness a hearing concerning the resignation of Co-Guardians for Christine Lisa Marie Leikari. Upon hearing the testimony of Attorney for the Veteran's Administration Mr. Faranelli. The Commission accepted the resignation of the Co-Guardians (Pamela Anne

Leach and Mr. Michael Leikari) and subject to a final accounting.

Purchase Order #6917, to Parks Hardware & Supply, in the amount of \$8.25, for the Maintenance Department.


Purchase Order #6918, to Mahone Tire Service, Inc., in the amount of \$46.00, for the Assessor's Office.


Purchase Order #6920, to W. V. Uniform & Equipment, in the amount of \$550.76, for the Correctional Center.


Purchase Order #6925, to Dils Ford, in the amount of \$857.97 per unit (3) per month.
