On this the 5th day of May, 1983, the County Commission Office was visited by several students from various local schools for "Know Your Government Day".

Also, on this day, the Commission witnessed the swearing in of Inez McKain, Howard Joachim, and A. W. "Bud" Taylor as board members on the Wood County Emergency Services Board.

Also, the Home Builders Association of the Mid-Ohio Valley presented a resolution to the Commission to support the provisions outlined in SB 150 and make low interest mortgage financing available to the residents of Wood County, West Virginia (copy attached). The Commission will support the resolution.

This Commission also today signed an Underground Facilities Agreement with Monongahela Power Company in which the Power Company agrees to install underground electric service to the Wood County Court House for the sum of \$4,636.00. (Copy attached.)

The Commission also ordered Jack Murray, of Murray's Sheet Metal, to line guttering on Court House with a rubberized substance which, Mr. Murray assures us, will stop all leaks. Work was performed at no cost for materials or labor.

Purchase Order #7035, to Clarke Paper Co., in the amount of \$28.76, for the Correctional Center.



UNDERGROUND FACILITIES AGREEMENT

Wood County Courthouse, hereinafter called "Customer," and MONONGAHELA POWER COMPANY, hereinafter called "Company," hereby agree as follows:

1. Company agrees to install underground 120/208 volt three phase service as per Est. 83-0189. Customer to trench and backfill.

in lieu of overhead facilities normally installed by Company, to provide electric service to the premises of Wood County Courthouse located at 3rd & Market Street Parkersburg, W. Va. (hereinafter called "Work").

2. Customer agrees to pay in advance to Company before commencement of Work hereunder the sum of \$ 4,636.00 in payment for the additional labor and materials required for the construction of such facilities underground in lieu of overhead.

3. Customer agrees that any and all trenching and backfilling performed by Customer shall be in accordance with Company specifications and standards.

4. Customer warrants that he/she/it has the right to authorize Company to enter upon the aforesaid premises and agrees to grant or cause to be granted to Company such easement or easements as may be required to perform the Work hereunder.
