On this, the 17th day of May, at 1:30 p.m., the Commission accepted two sealed bids on repairs on chiller unit in the Wood County Correctional Center. The first bid was from Air Conditioning Services, Inc., Parkersburg whose bid contained two options the first costing \$9,951.00 and the second costing \$13,605.60. Casto Technical Services, Charleston, submitted the second bid which also contained two options the first being \$7,690.00; the second \$12,648.00. After bids were studied and upon recommendation of Joe Carrico, a motion was made by Commissioner Holmes R. Shaver, seconded by Commissioner Dexter L. Buckley, Jr., and made unanimous by President, William C. Parrish, it was ORDERED that the bid be awarded to the low bidder, Casto Technical Services in the amount of \$7,690.00.

Also, on this day at 3:30 p.m., Dominic Kim, architect, presented to the Commission his plans for the interior renovation of the Wood County Court House.



Purchase Order #7066, to Parkersburg Office Supply, in the amount of \$39.63, for the County Clerk's office.


