On this the 26th day of May the Commission witnessed the swearing in of Phil D'Orazio, Stephen Farner, Margaret Monroe, James Shearer, Rev. Steve Tuel, Susan Watkins, and Dorothy Westfall as members on the Crime, Delinquency, and Corrections Board.

This day came the City of Vienna, a municipal corporation, by counsel, and tendered to the Commission its Petition and Application for annexation of territory to the City of Vienna by a minor boundary adjustment, pursuant to the provisions of Chapter 8, Article 6, Section 5, of the Code of West Virginia, as amended.

It appearing to the Commission that said Petition and Application is in proper form and that said Petitioner is entitled to file said Petition and make such Application, it is ORDERED that said Petition be and the same is hereby filed, and that a hearing upon such application be set for the 14th day of June, 1983, at 9:30 o'clock A.M. Supporting papers are attached to these minutes.

At 10:00 the Commission witnessed an Incompetency Hearing alledging the Competency of Mary Wigal. The Commission upon the hearing of testimony of the alledged incompetent's son, James P. Wigal, and upon written testimony of the physician, found the said Mary Wigal, to be Incompetent. Upon consideration of the petition of Committee for the said Mary Wigal, the Commission, on a motion by Commissioner Holmes R. Shaver, seconded by Commissioner Dexter L. Buckley, Jr., and made unanimous by President,

William C. Parrish, approved the appointment of James P. Wigal subject to the posting of a \$10,000.00 property bond.



ANNEXATION OF PROPERTY BY
MINOR BOUNDARY ADJUSTMENT

P E T I T I O N

Your Petitioner, City of Vienna, respectfully represents as follows:

I

That your Petitioner is a municipal corporation situate in the County of Wood and State of West Virginia, and files this Petition by virtue of the authority conferred by Chapter 8, Article 6, Section 5 of the Code of West Virginia, as amended, and pursuant to the direction of the Council of the City of Vienna, the governing body of such municipality, as set forth in a resolution of said Council.

II

That your Petitioner desires to annex certain lands to the City of Vienna, the territory to be so annexed being situate in Williams District, Wood County, West Virginia, no portion of which territory is within the corporate limits of any other municipality.

III

That there are three persons residing in or upon the territory to be annexed, all of which territory is more particularly shown on the attached plat marked for identification as "Exhibit A," and described by metes and bounds as follows:

BEGINNING at a point in the northerly line of 51st Street and in the present corporation line of the City of Vienna and in the southerly line of the tract of which this is a part, said point being S. 26° 41' W. 20 feet from the southeast corner of Lot No. 10 of Glenbrook Subdivision; thence N. 26° 41' E. with the corporation line of said city and the easterly line of Lots 10 and 12 (passing the northeast corner of Lot No. 12 and leaving the corporation line at 265 feet), a total distance of 271.91 feet to an iron pipe in the line of Van Dyke; thence N. 62° 26' W. 9.54 feet to an iron pipe, corner to Greenmont Racquet Club; thence N. 26° 34' E. 120 feet to an iron pipe; thence S. 62° 26' E. 290 feet to an iron pipe; thence S. 26° 34' W. 120 feet to an iron pipe; thence S. 27° 33' W. 267.70 feet to an iron pipe in the northerly line of 51st Street and in the present corporation line of the city; thence N. 63° 19' W. 276.54 feet to the place of beginning, containing 2.396 acres together with 0.127 acres in the 20 foot strip to be dedicated to public use as a part of 51st Street, or a total of 2.523 acres, more or less.


IV

That the area to be annexed is owned by Melvyn M. Okeon, David J. Szczepanek and Paul Van Dyke, all of whom have petitioned the City for annexation, and said area to be annexed abuts upon the northern and eastern corporate lines of said City.

WHEREFORE, your Petitioner prays that the Wood County Commission determine the proposed annexation to be a minor boundary adjustment; that the Commission fix a time for hearing upon this Petition; that notice of the proposed annexation be published in accordance with the applicable statutes; and that this Commission enter an Order changing the corporate limits of the City of Vienna and annexing the territory herein described to the City of Vienna.

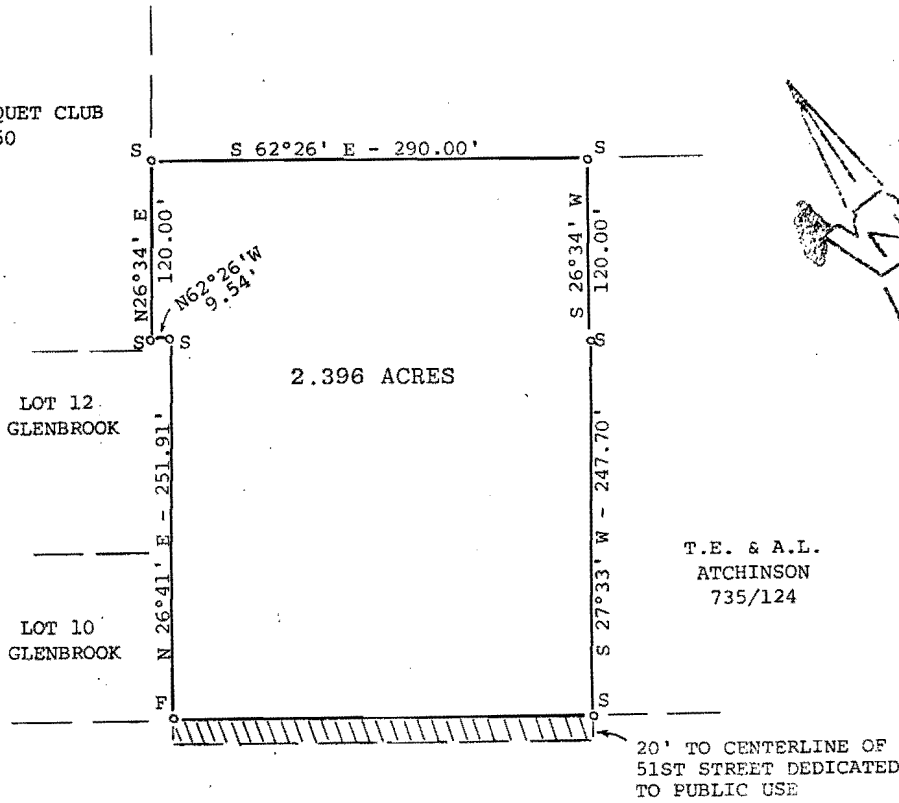

M., and that notice of said hearing, including a description of the territory sought to be annexed, be published in The Parkersburg News and The Parkersburg Sentinel, newspapers published in Wood County,

West Virginia, once a week for two successive weeks, with the first publication thereof to be more than fourteen (14) days prior to the said 14th day of June, 1983, and that notice also be posted in at least five public places within the area proposed to be annexed.

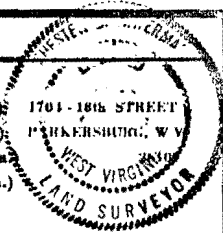
