This day came Robert Full and Larry Sullivan, attorneys, upon the request of the County Commission in regard to mental hygiene. concerning payment of psychiatric fees incurred by clients of Ernest Douglass, attorney. It had been requested that the County pay a portion of the fees. Commissioner Shaver called Mr. Douglass and told him to contact Mr. Sullivan regarding what steps to take next.

Upon request for quotes for carpet runners for floors 2,3,4, in the Wood County Judicial Building, the following were received: Barney Miller - \$2177.28; Mark Christopher - \$2400.00; Winans - \$1725.00; Model Carpet - \$1976.00.
