IN RE: Minutes of the Meeting held September 6, 1983

This day at 10 a.m. the Commission witnessed the incompetency hearing alledging the competency of Henry Eugene Kaufman. The Commission, upon hearing testimony of a physician, read by attorney Robert Friend, and testimony of alledged incompetent's wife, Anna May Kaufman, found the said Henry Eugene Kaufman to be incompetent. It was the unanimous decision of this Commission to appoint Mrs. Kaufman committee upon the posting of \$10,000 property bond.

The Commission witnessed the swearing in of Dr. David Avery as Physician to the Correctional Center.

At 1:30 p.m. bids were opened for air conditioners. It was the unanimous decision of the Commission to hold the bids over for further advisement and disposition will be made at a later session. Copy of Order attached.

At 2 p.m. bids were opened on bid package #1 for General Construction Items for the furnishing of all materials and performing all labor for the renovation of the Wood County Courthouse. The following bid was received: Arcon, Inc. - \$159,900. It was advised by Courthouse Construction Manager, Pat Minnite, that this bid be accepted with two deductions being made: 1. \$2000 for changing handrails from galvanized to black iron steel; and 2. \$5900 for omitting the 30-inch curb around sidewalk. It was the unanimous decision of the Commission to accept the bid. Copy of Order attached.

At 3 p.m. the Commission met with members of the Bar Association regarding space in the Courthouse. Another meeting will be scheduled when a convenient time can be agreed upon.
