The parties have still failed to reach any agreement among themselves. The parties were granted a continuance to Monday, September 10, 1984 at 10:30 a.m., and the hearing was adjourned with Commissioner Shaver strongly urging the parties to work out a solution that all parties involved could consider amicable.

The Commission sent a letter to the Finance Department instructing them to transfer \$5,000.00 from Entitlement 15, Jug Run Project, to Williamstown Volunteer Ambulance Service.
