This morning Attorney-at-Law William Pfalzgraf appeared before the Commission for the inducement of two Commercial Development Revenue Bond Issues. The first at 10:00 a.m. for P M Management. Pat Minnite was present on behalf of his company to answer any questions the Commission might have. This Bond Issue is in the amount of \$225,000.00 for an addition to Vienna Family Medicine on Ninth Street in Vienna. Everything being in order and hearing no objections Commissioner Shaver moved to adopt said Inducement Resolution as of November 15, 1984. Commissioner Buckley seconded and President Parrish made it unanimous.

The second Commercial Development Revenue Bond Issue Resolution presented was for Wagner Discount Tire, Inc. Jerry Wagner was present to answer any questions. This Bond Issue is in the amount of \$250,000.00. It will be used to construct and equip a retail tire and service center facility to be located at the corner of Ninth Street and Grand Central Avenue in Vienna, West Virginia. Everything being in Order and hearing no objections, Commissioner Shaver moved that the Commission adopt said resolution as of November 15, 1984. Commissioner Buckley seconded and President Parrish made it unanimous. Copies of both resolution agreements are on file with the County Clerk and the County Administrator.

Prosecuting Attorney for Wood County, Harry Dietzler, appeared before the Commission today to inform them of the resignation of one of the assistant

prosecuting attorneys, C. Scott Durig. Mr. Durig cited pay as the reason for his resignation. Mr. Dietzler told the Commission that in his opinion he would lose more employees if something was not done about their salaries. He requested that the Commission seriously consider giving each of the assistant prosecuting attorneys a \$5,000.00 raise, effective no later than January 1, 1985. Commissioner Shaver told Mr. Dietzler that the Commission would take his request under consideration and get back to him in the very near future.

Daily business was processed. Several purchase orders were signed. Copies are on file in the County Administrator's Office.


The Commission today accepted a bid from West Virginia Uniforms and Equipment for bullet-proof vests for the Sheriff's Department. The original bid was for 41 vests at \$225.00 each for a total of \$9225.00. West Virginia Uniforms, by their representative Dan McNeely, agreed to reduce the number of 41 to 30 at the same unit price of \$225.00, making the total cost \$6750.00. The original number included vests for the Correctional Guards. Due to a shortage of funds at this time, the Commission and the Deputies agreed to purchase vests for the Deputies and the Sheriff only at this time. A copy of the Order is attached. The low bid was rejected because according to the Wood County Sheriff's Deputies Association, it did not meet specifications as advertised.

The County Commission today accepted and awarded the bid for bullet-proof vests for the Sheriff's Department to West Virginia Uniforms and Equipment of Charleston, West Virginia. Their bid was for 41 vests at a total cost of \$9225.00. The Company of West Virginia Uniforms and Equipment by their representative Dan McNeely verbally agreed to reducing the number of 41 vests to a total number of 30 vests while the unit price of \$225.00 will remain the same. These vests are known as "Body Amour" style K15 with shirttails and shock plate. The total for 30 vests is \$6,750.00.


