Today the Commission signed an Order concerning minor boundary changes of Valley Estates to Lot Nos. 701-706. A copy of the Order is attached.

A letter was sent to Prosecuting Attorney Harry Deitzler telling him that the Commission, through a request from the Sheriff, needs to transfer fourteen (14) prisoners to the Harrison County facility. This transfer is necessary due to the fact that the Wood County Correctional Center's capacity is 56, and we are currently housing 68 prisoners.

Robert K. Tebay, III came before the Commission today to ask permission to act in its name for a project concerning the Wood County Airport Industrial Park. Mr. Tebay is the attorney for the Airport Authority. A copy of the Order giving him the authorization to act for the Commission is attached.

An invoice was signed and sent to George Sadie of Veterans Affairs for rent of space on the fourth floor of the courthouse for the month of October, 1984.

Six personal property improvers were received and signed today. Copies are attached.

Several purchase orders were signed today. Copies are on file in the Administrator's Office.

A letter was sent to the Williamstown Volunteer Fire Company to certify that the Commission had received and filed a map dated October 11, 1984, showing the boundary limits of the Rural Fire District known as Williamstown

Rural Fire Protection District. The Commission also certified and requested the Williamstown Volunteer Fire Company to be responsible for answering alarms received for properties within this District. A copy of the Order is attached.




No bond will be required for this revised plat of Valley Estates.






