IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA IN RE: The Minutes of the Meeting held September 6, 1984

Today came before the Commission, a group of concerned citizens to ask the Commission some questions about the property reappraisal. When they were told that, at this time, the Commission had no figures to give htem concerning the reappraisal, the group, lead by Mr. Ishmael Johnson, requested that the Commission bring in someone who could give them some answers. A letter from the group is attached. A copy of the letter the Commission sent out requesting certain individuals or their representatives come before the Commission and the group of citizens, is also attached.

The Mary Belle Nutter incompetancy hearing resumed today. It was continued from August 20, 1984. Donald Nutter the petitioner and son of Mary Belle, testified that his mother was basically incoherant. She has no idea who anyone is, and cannot take care of her personal self, or her financial affairs. David Underwood acting as guardian ad litem, said he agreed with Mr. Nutter, and felt it in Mary Belle Nutter's best interest to have a Committee appointed for her. Holmes Shaver made a motion that Mary Belle Nutter be declared legally incompetant. President Parrish seconded and made the vote unanimous. Commissioner Shaver then made a motion that Donald Nutter be appointed Committee for his mother, with President Parrish seconding making the vote unanimous. A \$5,000.00 property bond was posted.
