At 9:30 the Commission met Jack Barnes from the Wood County Community Action to discuss funding, and the present situation of the Community Action Chapter.

At 10:00 the Commission held an alleged incompetency hearing on Mrs. Bertha Bibbee. County Clerk Deputy Polly Eaton swore in Mrs. Helen J. Peer and Mr. McFarland Guardian ad litem. Helen J. Peer stated that Mrs. Bibbee was suffering from Organic Brain Syndrome and that her condition has not changed for three and one-half years, Mrs. Bibbee is unable to communicate. Mr. McFarland recommended that Mrs. Peer be committee for Mrs. Bibbee. A property bond will be posted in the amount of \$20,000. Mrs. Bibbee does not own property, but she will receive a part of her husbands estate, and is receiving benefits from the United Mine Workers. Commissioner Holmes R. Shaver made the motion for the appointment of Helen J. Peer as committee, Commissioner, Lewis E. Guinn seconded and Dexter L. Buckley, Jr. asked if any one else would like to be appointed as committee there was none heard. A unanimous decision was made to appoint Helen J. Peer as committee.

At 11:00 the Commission met with County Assessor Eugene Knotts to discuss the tax increase. Mr. Knotts dropped the proposal for the increase because of lack of support.


Having no further business or appointments the Commission adjourned at 4:00.
