The Commission this morning took care of daily business. Administrator Mary Rader updated the Commission on their mail and daily activities. Invoices and purchase orders were signed and copies are available in the County Administrator's Office.

This morning Attorney William Pfalzgraf came before the Commission with an Order for the Commission's signatures designating the Law Library in the Judicial Building Annex as the Donald F. Black Library in honor of retiring Judge Black. It was the unanimous decision of the Commission to do so.

Sheriff Greiner sent a letter to the Commission today appointing Deputy Sheriff Jack D. McCrady as Humane Officer for the year 1985. The Commission unanimously approved. Copy of the Order is attached.

At 10:25 a.m. this morning the Commission went into Executive Session for the purpose of amending and finalizing the budget for Revenue Sharing Entitlement 16. The Commission came out of Executive Session at 11:02 a.m. and announcement of the budget was made by President Buckley. The budget was unanimously decided on by the Commission. A copy of the finalized budget is attached.

The Commission today received notice of a law suit filed against the former Sheriff, L. W. Bechtold. The Commission is not named in the suit.



WHEREAS, during that period, Judge Black has ever striven to be guided in his service to the law by a deep respect for and keen appreciation of the law; and

WHEREAS, by his own example and by the standards he caused others to achieve, he has materially assisted in raising the standard of law practice in this County and area to its present high level; and

WHEREAS, the County Commission, in grateful acknowledgment of his contributions, deems it entirely appropriate to recognize and memorialize such qualities; now, therefore,

BE IT ORDERED: That the Law Library in the Wood County Judicial Building be, and it is hereby, dedicated to THE HONORABLE DONALD F. BLACK, and henceforth known and to be referred to as the DONALD F. BLACK LAW LIBRARY; and

BE IT FURTHER ORDERED: That a plaque of bronze or other suitable permanent material be placed on or alongside the door of said Law Library inscribed as follows, to-wit:

Dedicated to The Honorable Donald F. Black
Judge of the Fourth Judicial Circuit
(1953-1984);

and

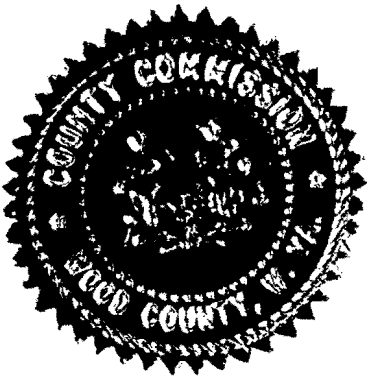
BE IT FURTHER ORDERED, That the Clerk of this




