Wood County Prosecutor Harry Deitzler came before the Commission to discuss some furniture and a typewriter he wishes to purchase for his office. The Commission told him they would discuss the matter and get back to him.

Judge Handlan discussed with the Commission a plan for security for the Judicial Building. He gave them an outline and explained the procedures. The Commission told the Judge that if the funding is available, they would like to go along with the plan. They intend to discuss it further.

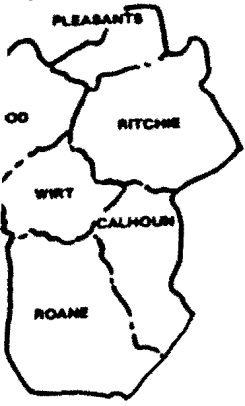

THIS CONTRACT AND AGREEMENT, in triplicate, made this the First Day of July, 1985, entered into between the Mid-Ohio Valley Board of Health, hereinafter referred to as the party of the first part, and the County Commission, of Wood hereinafter referred to as the party of the second part.


WITNESSETH: That pursuant of House Bill No. 194, enacted by the Legislature of the State of West Virginia, at its regular session for the year 1959, amending Article 2, Chapter 16, of the Code of West Virginia, the parties hereto agree and contract with each other as follows:

1. The party of the first part agrees to render and provide local health services and the use of public health facilities as provided in said Chapter 16, of the said code.

2. The party of the second part agrees to pay unto the party of the first part for rendering said services the sum of \$71,250 payable as follows: Quarterly.

It is mutually agreed and distinctly understood between the parties hereto that this contract is limited in duration to not more than one fiscal year from the date hereof, but it may be renewed by agreement of the parties.

IN WITNESS WHEREOF, This contract is signed, sealed, acknowledged and delivered by the Mid-Ohio Valley Board of Health and by the County Commission of Wood County, and by its authority duly given.


