The bid was submitted by Stout Pharmacy on Dudley Avenue, Parkersburg. The Commission stated that they would take the bid under advisement, and give a copy to Sheriff Steve Greiner for his consideration which they did.


Next Mr. and Mrs. R. K. Moore of Mineral Wells came before the Commission to ask that they consider re-appointing Mr. Roy Radabaugh to the Mineral Wells Public Service District Board. Mr. Dan Jones, also of Mineral Wells said he would like to go on record as also wanting Mr. Radabaugh re-appointed. He stated that they have a big project under way, and he felt it would be harmful to the project to change personnel in mid-stream. Commissioner Shaver thanked the parties for coming in, and told them the Commission would take their request under consideration.

At 11:00 a.m. the Commissioners met with Judge Gustke and Juanita Coe in Ms. Coe's office to discuss her needs for more storage space for records she is required to keep.

Having no further business or appointments, the Commission adjourned at noon.


