At 10:30 the Commission met with Jim Mylott concerning an Intergovernmental Agreement in regard to the Small Cities Block Grant funding. Commissioner, Holmes R. Shaver made the motion and Commissioner Lewis E. Guinn seconded and President, Dexter L. Buckley Jr. made it unanimous. President Dexter L. Buckley, Jr. signed the Agreement.


At 11:30 Eugene Knotts met with the Commission to schedule a meeting with the Commission and the Elected Officials concerning an increase in the tax assessment.
