IN RE: MINUTES OF MEETING HELD NOVEMBER 18, 1985

PRESENT: PRESIDENT, DEXTER L. BUCKLEY, JR.

At 10:00 the Commission met with several citizens concerned about the tax increase County Assessor, Eugene Knotts was proposing. Mr. Knotts took the floor to explain the County's position in personnel leaving their jobs to other jobs that were double in pay. He explained that the county was losing money by training them and losing them because of the low wages.

Mr. Richard, asked for the breakdown on the taxes and asked why the property owner was responsible for the tax increase.

J.P. Vaughn stated that the reappraisal that was going to be put into effect next year along with this tax increase, would be a lot. He also mentioned that he had property that he could not rent, Mr. Knotts stated that he could be eligible for a functional depreciation allowance.

Bob Morgan stated that the increase was a little over 32% of an increase. He mentioned the Hotel Motel tax the County was now receiving, and delinquent taxes should be taken care of. Mr. Knotts explained that the Hotel Motel Tax had nothing to do with the County.

E. Johnson stated that what the county needs to run the county should be, but the Wood County Rural Association does not want a tax increase.

Mr. Cross Vice President of the Wood County Rural Association that he also was not for the raise.

Prosecuting Attorney Harry Deitzler stated that the turnover in his office was high, and that he was still training new secretaries.

Mrs. Bee Snyder stated that she felt the property owners were already taxed too much, she gave ideas on using the lottery and other ways for the schools and salaries.

Commissioner Shaver stated that he understood their concerns but asked them to realize that the County's expenses have increased by \$30,000, and that there was no way to cut back on these expenses.


The meeting adjourned at 11:56.


