IN RE: MINUTES OF MEETING HELD JANUARY 13, 1986


PRESENT: PRESIDENT, HOLMES R. SHAVER

At 9:30 Ben Cowan met with the Commission to request 25,000 from Revenue Sharing. He also explained several projects and improvements that they wanted to do like put up lights, a camping area, water and sewage, he also mentioned several fund raising projects like horse shows and flea markets. Beginning the first for January they were Chartered by the Secretary of State.

At 11:00 Sheriff Greiner and Diana Joachim and County Assessor Eugene Knotts, met with the Commission to discuss delinquent taxes and what the County Commission could do to help them in collecting the taxes. Sheriff Greiner told the Commission that the next step was to turn it over to the Prosecuting Attorney or pay attorney to handle the cases. Diana Joachim stated that the had been typed up but were not filed.


