Buckley, and seconded by Commissioner, Lewis E. Guinn and made unanimous by President Holmes R. Shaver, the Commission declared Rosa Boso Incompetent. Ms. Boso owns a farm in sackson County but it is presently not being farmed. She holds a checking accounts and CD. The total being appraised at \$150,000/ She also receives \$300 from Social Security and a small amount from oil and gas leases. Ms. Boso also owns stock in a bank in Riply. President, Holmes R. Shaver asked Mrs. Facquare if she could see and problems in the distance of Parkersburg and Haden City. She said as long as her mother was alive

she would be in town at least once a week. All the relation agree that Mrs. Faggart should be appointed Committee for Ms. Boso. Mrs. Faggart was appointed Committee for Ms. Boso upon a motion made by Commissioner Dexter L. Buckley, Jr. and seconded by Commissioner, Lewis E. Guinn and made unanimous by President, Holmes R. Shaver. The order will be filed today.

The Commission went into executive session at 11:00. After lunch the Commission returned to executive session at 1:15.

The Commission signed a letter addressed to Prosecuting Attorney Harry Deitzler.

Having no further business or appointments the Commission adjourned at 4:00.
