On this date, the Commission received a check from the State of West Virginia for payment of Drawdown Request No. 2 for Grant No. B88-DC-54-0001. An Order was prepared for this matter.

On this date, the Commission authorized the exemption of gross taxes in regard to the real estate tax tickets for the year 1988 in the name of Towne Square Associates Lmtd. An Order was prepared regarding this matter.

On this date, the Commission gave authorization to Chemical Bank, New York, NY, to make payment of missing Coupon, Wood County Building Commission Revenue Bonds Series 1973, St. Joseph's Hospital of Parkersburg, dated 1/1/73,

5.90%, due 1/1/2002, in the amount of \$5,000.00 Bearer Bond No. 520, Lost Coupon 7/1/93. An Order was prepared for this matter.

A hearing was held on this date regarding Guardianship of Kathy Moyer. The attorney for the parents of Kathy Moyer was Elizabeth Pyles. The attorney for Kathy Moyer and the Aults was Pat Radcliff. Since there is a pending runaway warrant in Juvenile Court this was continued. Elizabeth Pyles will prepare the Order for this matter.


At 3:45 P.M. there was a hearing held for Guardianship for Gilmer D. Stowasser, Jr. William Richardson was the attorney.


Having no further business or any other scheduled appointments, the Commission adjourned at 4:00 o'clock P.M.
