MONDAY, JUNE 5, 1989

The Commission met in regular session on this date. They signed invoices, one (1) exoneration, one (1) improper and correspondence on this date.

At 9:00 A.M. Gene Knotts met with the Commission to discuss Dog Taxes. The meeting was re-scheduled for Thursday, June 8, 1989, at 10:00 a.m. so the Humane Society could attend.

The Sheriff's Tax Office presented the Official Form of Delinquent Personal Property and Real Estate Taxes.

At 10:00 A.M. the Commission held a hearing for Everett Silkett, Sr., alleged incompetent. Louie Davitian was the Attorney, and David M. Sanders was Guardian ad Litem. Nancy L. Silkett was sworn in. She stated her husband (Everett) has been in a coma on level 2-3 since May 28, 1987, resulting from a fall at work. He resides at Worthington Manor Nursing Home and is unable to care for any of his needs. Dr. George McCarty is his physician and he has told Mrs. Silkett that Mr. Silkett may always be in this coma. Commissioner Shaver made the motion, Commissioner Grimm seconded and President Guinn made it unanimous to declare Everett Silkett, Sr. incompetent. Nancy L. Silkett stated her husband's income is approximately \$700.00 per month from Workers' Compensation, he has an old car and their home is worth around \$20,000.00. Hearing no objections, the Commission appointed Nancy L. Silkett as Committee for Everett Silkett, Sr. A surety bond for \$9,000.00 is to be posted.

At 10:30 A.M. Brian Moore and Lisa Rhodes was sworn in for the Tax Office for temporary summer work.

At 11:00 A.M. the Commission held a hearing for a petition to close a portion of 16th Street. The petitioner is Nellie M. Allen and Orville Hardman is the attorney. The said eighty (80') foot right-of-way of 16th Street situate and being on the westerly side of the CSX Railroad Tract be, and it is hereby reduced to forty (40') feet in width by closing twenty (20') feet on the northerly side of the right-of-way and twenty (20') feet on the southerly side of the right-of-way is closed as a public right-of-way per the Wood County Commission on this date.

At 1:00 P.M. the Commission had a meeting with Mary Rader; S.F. Greiner, Diana Joachim, and Glenna Low of the Tax Office; Jeannie Curtis of the Assessor's Office; Jamie Six and Roberta Burk of the Clerk's Office to discuss projected revenues and expenditures.


The Commission went into Executive Session at 2:36 p.m. and adjourned at 3:18 p.m. to discuss personnel matters.


Having no further business or scheduled appointments, the Commission adjourned at 4:00 o'clock p.m.
