IN RE: MINUTES OF MEETING HELD THURSDAY, OCTOBER 19, 1989

The Commission met in regular session on this date. They signed purchase orders, invoices and correspondence on this date.

At 9:00 A.M. Mary Rader, County Administrator, met with the Commission to discuss the various office procedures and daily business.

At 10:00 A.M. the Commission held a hearing for Herbert C. Brown, alleged incompetent. William L. Jacobs was the Attorney and Ernest Douglass was the Guardian ad Litem. Mildred Brown, a niece by marriage, was sworn in. Mildred Brown resides in Shepherdstown, WV, and has handled Herbert Brown's personal affairs for years. Herbert Brown resides in Arlington Nursing Home. He had a stroke in July, 1989, and is paralized on the right side and is unable to speak or care for any of his needs. Dr. Robert Gustke is the physician. Commissioner Grimm moved and President Guinn seconded to declare Herbert C. Brown incompetent. Herbert C. Brown owns real estate in Mineral Wells, WV, approximately two acres with a brick ranch style home valued at approximately \$40,000.00 to \$50,000.00. He has a checking account of \$488.00 and receives a total of \$641.00 per month from Social Security and an FMC pension. Hearing no objections, the Commission appointed Mildred Brown Committee for Herbert C. Brown. She is to post a \$40,000.00 corporate surety bond. At 11:00 A.M. the Commission held a hearing for Lottie Skeen, alleged incompetent. William Mercer was the Attorney and Ralph E. Troisi was the Guardian ad Litem. Lottie Skeen is a resident of Parkview Center and is suffering from alzheimers disease. Dr. Loretta Auvil is the physician. Commissioner Grimm made the motion and President Guinn made it unanimous to declare Lottie Skeen incompetent. Avard N. Skeen was appointed Committee and is to post a \$1,000.00 property surety bond.

The Commission authorized President Guinn to sign the deed conveying an access right-of-way from the County Commission to the Claywood Park Public Service District on this date. An Order was prepared for this matter.

The Commission ORDERED that an additional letter of appreciation signed by the Mayor of Parkersburg regarding Brent Lowther be made a part of the official records of the County Commission of Wood County.

The Commission authorized Commissioner Grimm to sign the final financial report for Grant No. DFC-87-011. An Order was prepared for this matter.

The Commission authorized President Guinn to sign the Quarterly Financial Report No. 1 and the Request for Reimbursement for Grant No. 88-DLE-Oll. An Order was prepared for this matter.

The Commission authorized President Guinn to sign monthly Financial Report No. 13 and the Request for Reimbursement for the month of September, 1989, for Grant No. 87-DLE-016. An Order was prepared for this matter.

Having no other scheduled appointments or further business to attend to, the Commission adjourned at 12:00 o'clock noon.
