The County Commission met in regular session on this date. The Commission signed purchase orders, invoices and correspondence.

At 9:00 a.m. the Commission met with Larry Lockhart and neighbors regarding Keith Street. The Commission informed them that they would need to seek legal counsel regarding this matter.

At 9:15 a.m. Mary Rader, County Administrator, met with the Commission to discuss various office procedures.

The County Commission received a check from the State of West Virginia in the amount of \$19,338.78 as per Drawdown Request No. 5 submitted by the County Commission to the Governor's Office of Community and Industrial Development in regard to the Small Cities Block Grant known as the Union-Williams Public Service District Sewer Project, Grant No. B88-DC-54-0001. An Order was prepared for this matter.

The County Commission awarded the bid for an IBM System 36 Computer, for use in the Circuit Court office, to IBM Corporation, Charleston WV, and further awarded the software program, to be used in conjunction with the IBM System 36, to Nuggett Software System. An Order was prepared for this matter.

At 1:00 p.m. the Commission met with Jerry Martin from Applied Business Systems in regard to his 1988 taxes. Present at this hearing was Jerry Martin, Thomas Ryan, Eugene Knotts County Assessor, Cindy Brown and Mary Rader. The Commission informed Mr. Martin that they would discuss this matter with Jeff Reed, County Prosecuter and Eugene Knotts before they gave

a decision on this matter.

At 1:40 p.m. the Commission met with Mr. Fenton, Past Chairman of the Williamstown Ambulance Service, and Paul Stockwell, new Chairman, to ask for funding for a heart monitor for the Ambulance Service. Mr. Fenton also asked for the Commission to write a letter to the Mid-Ohio Valley Emergency Medical Services to request they allocate the numbers 12 and 13 to the Williamstown Ambulance Service. Number 12 was allocated to the Washington Bottom Ambulance Service, but they are no longer in service. The Commission stated they would check to see if Washington Bottom was planning to go back in service before they wrote the letter.

On this date the County Commission received an abstract from West Virginia Department of Highways in regard to the extension of County Route 50/8, total length of 0.197 mile to be assigned to the State Local Road Service. An Order was prepared for this matter.

Having no other scheduled appointments or further business to attend to, the Commission adjourned at 4:00 p.m.
