IN RE: MINUTES OF MEETING HELD, THURSDAY, APRIL 12, 1990

The County Commission met in regular session on this date. The Commission signed purchase orders, invoices and correspondence.

At 10:00 a.m. the Commission held a Public Hearing on the closing of a portion of 4th Avenue. The Petitioner in this matter was AB Chance Company. The Attorney was George Zivkovich. This portion of 4th Avenue is behind AB Chance Company and joins their property. They want to close it to have all their property connected. This road is an Orphan road and has not been used for 20 years. Ray Casto stated that he opposed the street closing until it was explained to him that there would be no traffic on this portion; then he had no further objection and he agreed to the closing. Commissioner Shaver made the motion that the portion of 4th Avenue be closed. President Guinn seconded and made it unanimous. The Order will be filed today.

At 11:05 a.m. the Commission held a hearing for Christa Fint, who is mentally retarded. William Fint was the Petitioner and represented himself. Gerald Townsend was the Guardian Ad Litem. Mr. Fint and Gerald Townsend were sworn in. Mr. Fint stated that Christa Fint had just turned 18 years of age and has cerebral palsy; she is totally dependent. The Guardian Ad Litem stated that Christa needs help in feeding herself, however, she is not ambulatory but does need a guardian appointed for her. Christa has two sisters that have been notified of this hearing and the green cards are in the file. The affidavits from two doctors are also in the file. Commissioner Shaver made the motion that Christa Fint be declared incompetent and President Guinn seconded. The Commission then heard testimony to appoint a new Committee. Christa has no /12/90

assets and her SSI goes directly to the foster home. Commissioner Shaver made the motion that William L. Fint be appointed as Committee for Christa D. Fint. An Order will be filed today. The file in this matter is in the Probate Office.

On this date, the County Commission authorized President Guinn to sign Disbursement Request No. 1 in regard to renovation to the Manna Pro Building which is to be used by the Magistrate Court System. Request No. 1 is in the amount of \$56,050.00 and represents work completed through March 28, 1990. All documentation in relation to said renovations is on file in the County Administrator's Office. An Order was prepared for this matter.

Having no other scheduled appointments or further business to attend to the Commission adjourned at noon.
