On this date, the County Commission met in regular session. They signed purchase orders, invoices, and correspondence.

At 9:00 A.M., the County Commission met with Mary Rader.

At 9:30 A.M., the County Commission met with Attorney Walt Auvil to discuss the Charles W. Harlow Estate. Darla Beaver, Guardian Ad Lidem and Bonnie Harlow were sworn in. Mrs. Harlow wants to be appointed Committee. She says that her husband needs constant supervision and care. He has many health problems. Both Mrs. Harlow and Mrs. Beaver stated that Mr. Harlow gets confused easily. Mr. Harlow is 77 years old. Mrs. Harlow has been taking care of his financial needs for some time now. Upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver, and made unanimous by Lewis E. Guinn, the Commission declared Mr. Charles W. Harlow incompetent. Upon a motion made by Steven A. On this date, the County Commission was in receipt of a check in the amount of \$2,804.62 from the State of West Virginia in regard to Drug Law Enforcement Grant No. 88-DLE-011. Said check represents reimbursement to the County and is pursuant to an Order appearing in Order Book 51, at Page 368, and bearing the date of October 18, 1990 at which time the Request for Reimbursement was submitted to the Criminal Justice and Highway Safety Office. An Order was prepared regarding this matter.
