On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and correspondence. They also signed improvers on this date.

At 10:00 a.m. the Commission held a hearing for Ronald A. Brown, alleged mentally retarded. Bill Richardson, Jr. was the Attorney and the Guardian ad Litem was William Crichton V. Rodney Brown and William Crichton were sworn in. Ronald Brown is an 18 year old who is mentally retarded due to an accident at birth or shortly thereafter. He is a nice looking young man, with mischievous dancing eyes. He was very interested in what was going on around him. He seemed to understand that nothing was going to change. His father would still be taking care of him as in the past. Ronald Brown attends Martin School. He is learning the basic skills of tying his shoes, buttoning his clothes, etc. Rodney Brown is employed by DuPont. He owns his home at Wakefield Addition in Washington, WV. Commissioner Grimm made the motion to declare Ronald A. Brown mentally retarded, Commissioner Shaver seconded and President Guinn made it unanimous. Rodney Brown was appointed Committee for Ronald A. Brown and is to post a \$5,000.00 Justification of Surety Bond. This hearing ended at 10:14 a.m. This file is in Probate Office.

On this date, the Commission opened sealed bids for the purchase of three (3) police cruisers for use by the Wood County Sheriff's Department. Bids were received from McClintons and Dils Ford. The Commission awarded the bid to Dils Ford. An Order was prepared for this matter.

On this date, the Commission received and entered into a fully executed Subgrantee Agreement with the State of West Virginia for the 1990 Governor's Summer Youth Program. An Order was prepared for this matter.

On this date, the Commission authorized payment of Wood County Development Authority, WV, 7.20% Parking Revenue Bond dtd 10/1/74 Due 10/1/89, Bearer Bond 92 @ \$5,000.00 Lost with Coupon Due 10/1/89 Correspondence Control Number: 9404. A letter was sent to Chemical Bank in regard to this. An Order was prepared for his matter.


At 11:30 a.m. S.F. Greiner and Rick Woodyard met with the Commission.


Having no other scheduled appointments or further business to attend to, the Commission adjourned at 4:00 p.m.
