On this date, the County Commission met in regular session. They signed purchase orders, invoices and correspondence.

At 10:30 A.M., Elwood Miller was sworn in to the Wood County Airport Authority.

On this date, the County Commission reinstated Russell Byers, Jr. as Administrator for Constant Byers, his mother.

On this date, the County Commission ORDERED that the fees for keeping and maintaining prisoners in the Wood County Correctional Center (Jail) for the months of April, May and June 1991 will be \$36.06 per prisoner per day. It was also ORDERED that the appropriate agencies and authorities be notified by sending them a copy of the Order that was prepared regarding this matter.

On this date, the County Commission authorized Steven A. Grimm to sign Applications for Wood County Sheriff's Deputies M.F. Smith and Charles J. Johnson to attend the WV State Police Training Academy, NRA Firearms Instructor Development Training on August 12-16, 1991. An Order was prepared regarding this matter.

On this date, the County Commission authorized Steven A. Grimm to sign the Request For Funds in the amount of \$4,135.57 for the period of September 1, 1990 through December 31, 1990 in regard to Sobriety Checkpoint Grant No. AI88-11. In addition to the Request For Funds, a Grant Progress Report No. 5 is being submitted to the Criminal Justice and Highway Safety Office. An Order was prepared regarding this matter.

On this date, the County Commission authorized Steven A. Grimm to sign the Request For Funds for the period of January 1, 1991 through March 31, 1991 in regard to the Public Against Drunk Driving (P.A.D.D.) Grant. Said Request is in the total amount of \$9,971.29. In addition to the Request For Funds,


a Grant Progress Report and a Grant Financial Report No. 2 are being submitted to the Criminal Justice and Highway Safety Office. An Order was prepared regarding this matter.


Having no scheduled appointments or further business to attend to, the County Commission adjourned at 12:00 Noon.
