On this date, the County Commission met in regular session. They signed purchase orders, invoices, and correspondence.

At 9:00 A.M. the County Commission met with Mary Rader.

At 9:30 A.M. the County Commission met with Gene Knotts and R.K. Mason to discuss an improper for Bell Atlantic, an exoneration for the Smoot Theatre, and exoneration for Jerry Robinson. The Commissioners approved all three.

At 10:15 A.M. Charlie Burd was sworn in as President of the Wood County Development Authority Area Roundtable.

At 10:20 A.M. the County Commission heard the case of Richard K. Wolfe who is incompetent. Mario Farinella, Attorney, presented his case. Wood County Bank does not wish to be Mr. Wolfe's Committee any longer. He disrupts the bank and they have had to get him out of jail all over the country. Larry Thorton represented Wood County Bank. Mr. Farinella would like for the Sheriff to be Mr. Wolfe's Committee. Chief Deputy Wilcox stated that it would be a burden on the Department. After a short recess, the County Commission continued this hearing to Thursday, January 24, 1991, at 10:00 A.M., so that they may discuss this with their legal counsel.

At 10:45 A.M. the County Commission met with Councilwoman Peggy Mace and Mayor William Owens to discuss getting funding for their Freedom Festival. The County Commission said they would put it in to be reviewed when the budget is to be done.

On this date, Howard Van Dyne appeared before the Commission to express his concerns about the Wood County Airport Authority. These concerns being the lack of a job description for the Manager's position, the delay of the

appointment of a full time Manager, and the delay of an appointment to the Authority. It was suggested that Mr. Van Dyne express his concerns at a meeting of the Wood County Airport Authority.

On this date, the County Commission authorized Steven A. Grimm to sign the Equipment Listing and the Request For Reimbursement in regard to Drug Control and System Improvement Program Grant No. 89-DC-031. In addition to the Equipment Listing and the Request for Reimbursement, a Monthly Progress Report are also being submitted to the Criminal Justice and Highway Safety Office. No expenditures were made during the months of November and December, 1990. An Order was prepared regarding this matter.




