On this date, the County Commission met in regular session. They signed purchase orders, invoices and correspondence. The Commission approved minutes from Monday, April 29, 1991 upon a motion made by Holmes R. Shaver, seconded by Jean Grapes and made unanimous by Steven A. Grimm. They also approved minutes for Thursday, May 2, 1991 upon a motion made by Jean Grapes, seconded by Holmes R. Shaver and made unanimous by Steven A. Grimm. The Commission approved two exonerations for Charles Roger Ford.

At 9:15 A.M., the County Commission met with Lyle McPherson and Dan Kniska to discuss their taxes. They feel that either they are being taxed too much or that their competitors are not being taxed enough. Gene Knotts and R.K. Mason were also present at this meeting. After a discussion, the County Commission suggested that they get comparables and meet with the Board of Review and Equalization in February. They agreed that this would be the best way to handle this.


At 10:00 A.M., the County Commission heard the case of Charles Tygart, alleged incompetent. Larry Sullivan was the Attorney and Patrick McFarland was the Guardian Ad Litem. Norma J. Bailey, niece of Mr. Tygart and Freda Winans, sister of Mr. Tygart were sworn in. Mrs. Bailey stated that Charles Tygart was 79 years old and had congestive heart failure and pneumonia. He is also being treated for organic brain syndrome. He is unable to care for himself or his affairs. An affidavit from Dr. Barnett stated that this is a permanent condition. Mr. Tygart's wife is also in a nursing home, she suffers from Alzheimers. Mr. Tygart is in the Ravenswood Health Care Center. Mr. McFarland stated that he was moved from Arlington Nursing home to the Ravenswood Center. Mrs. Bailey




Having no scheduled appointments or further business to attend to, the County Commission adjourned at 4:00 P.M.
