Grimm and made unanimous by Holmes R. Shaver, the County Commission approved minutes from Monday, September 23, 1991. Upon a motion made by Holmes R. Shaver and seconded by Steven A. Grimm, the Commission approved minutes from Thursday, September 19, 1991.

At 9:30 A.M., John Powell was sworn in as a member of the Wood County Civil Service Commission for Correctional Officers.

At 9:45 A.M., Jeff Devol was sworn in as a member of the Wood County Parks and Recreation Commission (Mountwood Park).

At 11:00 A.M., the County Commission met with Gene Harper to discuss his back taxes. The Commission told Mr. Harper that they would exonerate the past years taxes but he would still need to pay his 1990/1991 taxes.

On this date, the County Commission was in receipt of a letter from Terry Miller, President of the Wood County Deputy Sheriff Association.
