On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and correspondence.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, adopted a Resolution in reference to Budget Revision No. 30 in the General County Fund budget for the fiscal year 1991/1992. The Request, being submitted to the Department of Tax and Revenue was signed by Steven A. Grimm, President. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, signed an amendment to the Administration Agreement that the County Commission has with the Mid-Ohio Valley Area Development Corporation to administer and manage the Small Cities Block Grants on their behalf. Said amendment would increase the funding to the above corporation from Grant funding as referred to in an Order on this date in reference to a budget amendment. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm to sign a budget amendment in regard to the Waverly Sewer Project being completed by the Union-Williams Public Service District through the Small Cities Block Grant No. B88/89-DC-0001. Said amendment would allow the amount of \$999.00 to be transferred from the Construction line item to the Administration line

item. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm, in his official capacity as President, to sign a Resolution giving approval, on behalf of the Wood County Commission, to make payment in the amount of \$2,999.14 to the Mid-Ohio Valley Area Development Corporation for services rendered and to sign a Drawdown to be submitted to the State for reimbursement of said paid invoices. Said Resolution pertains to Small Cities Block Grant No. B88/89-DC-54-0001 for the Waverly Sewer Project being completed through the Union-Williams Public Service District. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm to sign the Final Performance Report in regard to the Small Cities Block Grant No. B88/89-DC-54-0001 to be submitted to the Governor's Office of Economic and Industrial Development, Charleston, WV. Said Final Performance Report is in regard to the Waverly Sewer Project being completed through the Union-Williams Public Service District. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, entered into a Consultation Agreement by and between Tiano-Knopp Associates, Inc. (TKA) and the Wood County Commission (WCC). Said Agreement states that the Wood County Commission is the grantee of funds from the State of West Virginia, Governor's Office of Community and Industrial Development, Criminal Justice and Highway Safety for the coordination and continuation of a comprehensive community highway safety program and that Tiano-Knopp Associates, Inc. will provide full-time (40 hours per week) administrative, management and planning consultation services in regards to such grant. TKA shall receive the sum of \$8,320.00 from said grant funding. The term of said Agreement shall be for the period of April 1, 1992

and continuing through September 30, 1992 with the provision that the Agreement may be terminated by either party within thirty days written notice given one to the other. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm to sign the Request for Application, Fiscal Year 1992, in regard to the Offender Treatment Program under the Drug Control and System Improvement Formula Grant Program being distributed through the Criminal Justice and Highway Safety Office, Charleston. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm to sign a letter of request addressed to Barbara Lobert, Highway Safety specialist with the Criminal Justice and Highway Safety Office, Charleston, WV. letter requests the grant period of the Sobriety Checkpoints Grant No. AI91-14 be extended to September 30, 1992. Said Grant in the amount of \$4,896.00 provides overtime funds for deputies of the Wood County Sheriff's Department. However, the Sheriff's Department will be unable to expend all of these funds prior to the June 30, 1992 deadline set forth in the Grant due to the fact the original contract was lost and the contract was not signed until after the grant program was to begin. Another problem is the scheduling of the "Batmobile" which enables deputies at the checkpoint to do a blood alcohol level exam on-site. If the "Batmobile" is unavailable, arrangements have to be made to transfer those who need to have an alcohol level exam to the Sheriff's Papartment which is located in downtown Parkersburg. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, authorized Steven A. Grimm to sign the Request for Reimbursement in regard to the Sobriety Checkpoints Grant No. A191-14. Expenditures in the amount of \$676.33 were made by the County during

the month of March, 1992. In addition to the Request for Reimbursement, a Monthly Progress Report, a Sobriety Checkpoint Activity Report and a Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, WV. An Order was prepared regarding this matter.

On this date, the County Commission announced that they, as a Commission, are calling a SPECIAL SESSION to be held on Tuesday, April 21, 1992 at 8:30 A.M. for the purpose of Laying the 1992/1993 Fiscal Year Levy in accordance with Chapter 11, Article 8, Section 14, of the West Virginia Code, as amended. An Order was prepared regarding this matter.

There were no scheduled appointments on this date.

Having no other business to attend to, the County Commission adjourned at 12:00 Noon.
