On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

At 8:45 A.M., Dianne E. Boggess was sworn in the Wood County Commission on Crime, Delinquency and Correction.

At 9:00 A.M., the appointment with Todd Hooker and Fred Rader was cancelled.

At 9:30 A.M., Curt Klutner was sworn in to the Wood County Commission on Crime, Delinquency and Correction.

On this date, the County Commission was in receipt of a check from the State of WV in the amount of \$3,520.00 which represents reimbursement to Wood County for expenditures made during the months of June, 1992 and July, 1992 in regard to the Drug Control and System Improvement Grant No. 91-DC-076. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check from the State of WV in the amount of \$1,385.10 which represents reimbursement to Wood County for expenditures made during the month of August, 1992 in regard to the Drug Control and System Improvement Grant No. 92-DC-061. An Order was prepared regarding this matter.

On this date, the County Commission put John V. Roberts in nomination to be reappointed to the Wood County Building Commission. Said nomination is pursuant to an Order dated November 30, 1992 when said vacancy was announced due to the fact that Mr. Roberts' term will expire on December 20, 1992. An Order was prepared regarding this matter.



Said nominations are pursuant to an Order bearing the date of November 30, 1992 when said vacancies were announced due to several terms expiring on December 16, 1992. On this date, an Amended Order was prepared stating that Jesse Boone's term expired on December 16, 1992; therefore a member needs to be appointed to fill the unexpired term of Mr. Boone which will end on December 16, 1994 for the Wood County Parks and Recreation Commission (Mountwood Park). Ronald Buchanan, President of said Board stated that Mr. Boone did not attend any meeting in 1992 and consequently does not wish to be reappointed.

Having no scheduled appointments or further business to attend to, the County Commission adjourned at 4:00 P.M.
