On this date, the County Commission met in regular session. They signed purchase orders, invoices and correspondence. Upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and made unanimous by Jean Grapes, the County Commission approved minutes from Thursday, July 2, 1992 and Monday, July 6, 1992. The Commission also approved Exonerations for Roy E. & Ruth Shaffer and Merrill A. & Elsa B. Raney and a Personal Property Improper for United Properties, Inc. DBA Blennerhasset Hotel.

At 9:00 A.M., the County Commission met with Mary Rader to discuss County business.

At 9:30 A.M., the County Commission met with Attorney Dave Underwood and Mayor William Owens to discuss the annexation of property located in the City of Vienna. Mr. Underwood stated that they had filed a petition on June 11, 1992 and today they were before the County Commission for a public hearing. Mr. Underwood stated that the property had been posted and notices were published in both The Parkersburg News and The Parkersburg Sentinel notifying the public of this public hearing. Mayor Owens was sworn in and stated that Walmart owns the property and also stated that it is in the City of Vienna. Mr. Underwood stated that they are doing this at the request of Walmart. Upon a motion made by Jean Grapes, seconded by Steven A. Grimm and passed, the Commission accepted this petition for the annexation of the property in Vienna. An Order, which describes where the land is located, was prepared regarding this matter.


On this date the County Commission announced to all concerned that a vacancy exists on the Western District Guidance Center Board of Directors. Upon a motion duly made, seconded and passed, the County Commission appointed Richard Pence as their representative on this Board. David Morford was appointed as their representative on January 2, 1992 but he no longer wishes to serve in this position. Said appointment is made on a yearly basis by the County Commission. An Order was prepared regarding this matter.


