At 8:45 A.M., the County Commission canvassed ballots from the election held on November 3, 1992. They adjourned at 10:04 A.M.

At 10:04 A.M., the County Commission held a hearing for Earl Balsey, alleged incompetent. Attorney for the petitioners was William Richardson, Sr. The Guardian Ad Litem was William Crichton who presented his opinion to the Commission stating that he agrees with the petition. An affidavit in regard to the health of Mr. Balsey was submitted to the Commission. Upon a motion duly made, seconded and passed, declared Earl F. Balsey incompetent. Richard and Linda Carpenter were appointed Co-Committee with a bond of \$1600.00.

At 10:40 A.M., the County Commission again met to canvass ballots.

At 11:30 A.M. the County Commission adjourned for lunch.

At 12:30 P.M., the Commission reconvened.




At 1:45 P.M., the County Commission canvassed votes.
