On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

At 9:00 A.M., the meeting with Dan Marshall was rescheduled for Monday, November 16, 1992.

At 10:00 A.M., the County Commission met with Dan Siers to discuss the blocking of Bull Creek Road. The County Commission stated that they would have Gail Hartshorn, County Inspector, go out and look at the road. The Commission set up a hearing for November 30, 1992 at 1:30 P.M. to discuss this matter. Bob Waters, Assistant Prosecuting Attorney will be present at this hearing and will be able to tell Mr. Siers what he can do.

On this date, the County Commission, upon a motion made by Holmes R. Shaver, seconded by Jean Grapes and made unanimous by Steven A. Grimm, adopted a Resolution in reference to Budget Revision No. 9 in the General County Fund budget for the fiscal year 1992/1993. The Request for Revision was signed by Steven A. Grimm, President. An Order was prepared regarding this matter.


On this date, the County Commission, upon a motion made by Holmes R. Shaver, seconded by Jean Grapes and passed, authorized Steven A. Grimm, as President, to sign the Request for Reimbursement in regard to the Drug Control and System Improvement Grant No. 92-DC-061. Expenditures in the amount of \$1406.00 were made by the County to Cathy O. Doty who provided, by contract, seventy-four hours of substance abuse services to the Wood County Adult Probation Office during the month of October, 1992. However, the Request for Reimbursement is in the amount of \$1,265.40 since there is a ten percent

matching fund requirement to be met by the County as set forth in the Grant. In addition to the Request for Reimbursement, the Monthly Progress Report No. 3 and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, WV. An Order was prepared regarding this matter.


Having no scheduled appointments or further business to attend to, the County Commission adjourned at 12:00 Noon.
