MONDAY, FEBRUARY 28, 1994

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

At 9:00 A.M., the hearing for Normus S. Vincent, deceased, was continued to April 18, 1994 at 10:00 A.M.

At 9:15 A.M., Rick Modesitt was sworn in to the Wood County Commission on Crime, Delinquency and correction.

At 9:15 A.M., the County Commission met with Jerry Smith, Home Detention Officer for the Wood County Sheriff's Department. Mr. Smith informed the County Commission that when he was employed in December, 1991, his salary was based on the starting Correctional Officers salary, yet he is a non-civil service employee of the County Commission under the supervision of the Sheriff. Mr. Smith then stated that his salary has remained the same even when other County employees received a pay raise. Mr. Smith then stated that he is requesting a pay increase. Mr. Smith explained his job to the Commission. More discussion took place but was inaudible on the tape.

On this date, Roger Shuman was sworn in to the Civil Service Commission for Correctional Officers.

At 9:30 A.M., the County Commission adjourned and met as the Board of Equalization and Review. At this time they met with John Lofty - Vienna District.

At 10:00 A.M., the Board met with Harlen & Barbara Bowser - Parkersburg City District. PM Management Company failed to show for their 10:00 A.M. appointment.

At 10:30 A.M., the Board met with Joseph W. Bowser - Union District, City District; Lowell P. & Mabel V. Hall - City District; Nita J. & David Grapes - Lubeck District; William R. & Lura Russell - Clay District; Fred C. & Janet R. Walters, Sr. - City District and Charles M. & Ruth Wasson - Lubeck District.

At 12:00 Noon, the Board adjourned.

At 1:00 P.M., the appointment with Sheriff Merritt, Doug Herrington, Bob Tranquill and Vickie Cummons to discuss computers was rescheduled for March 3, 1994 at 10:30 A.M.

At 1:15 P.M., the appointment with Sheriff Merritt and Lee Myers to discuss pay was rescheduled for March 3, 1994 at 11:00 A.M.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized Holmes R. Shaver, as President, to enter into an Extended Service Plan with CWS Business Machines and Products, in regard to a Model DC-4085 copy machine and a Model NP-6030 copy machine. Both copy machines are located in the offices of the County Clerk of the County Commission of Wood County. The yearly maintenance charge for the Model DC-4085 will be in the amount of \$450.00 and the yearly maintenance charge for the Model NP-6030 is in the amount of \$600.00. The effective dates of said maintenance for both copy machines is to begin on February 1, 1994 and will continue through January 31, 1995. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion duly made, seconded and passed, ORDERED that the changes in the Property Assessments for the year 1994 be made. A copy of the Order listing said changes is attached to these minutes and should be made a part thereof.

At 3:31 P.M., the County Commission, upon a motion made by Holmes R. Shaver, seconded by Jean Grapes and made unanimous by Steven A. Grimm, went

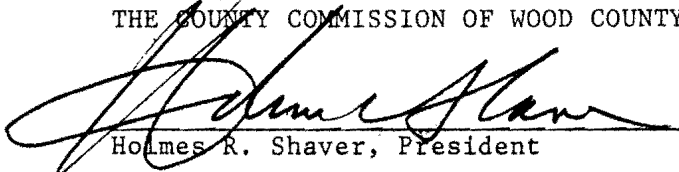

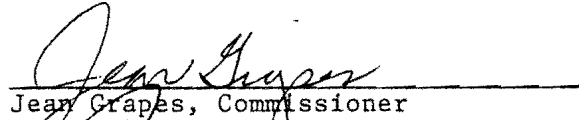

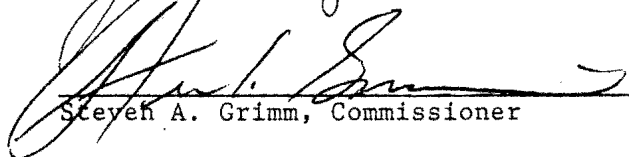
