## IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD MONDAY, JANUARY 10, 1994

PRESENT: HOLMES R. SHAVER, PRESIDENT JEAN GRAPES, COMMISSIONER STEVEN A. GRIMM, COMMISSIONER

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission met with Kenneth Hegemann, President of American Municipal Power - Ohio (AMP-Ohio). Mr. Hegemann stated that AMP-Ohio is a non-profit corporation and is made up of municipal electric systems (seventy-five own and operate a municipality utility and they own the AMP-Ohio. Mr. Hegemann then stated that the Belleville Hydroelectric project is a joint venture type that is owned by forty-two of the seventy-five members. The City of Jackson asked AMP-Ohio to help them and forty-two said that they would like to proceed, they then looked over the license that the City of Jackson received and they formed the Ohio Municipal Electric Generating Agency-Joint Venture 5; they then asked AMP-Ohio to act as consultor to get this job done. There are three parts to the project: Belleville Project, back-up generation and the hydroelectric project. They would like to start construction April 11 and would expect to see generated electricity in 1996. There will be about 150-200 people working on the site for approximately two years. This project is subject to the approval of the Corps of Engineers. They will be paying the Corps of Engineers over \$600,000.00 to review the plan and to pay their people to review the project. Mr. Hegemann went on to say that there will be 15-20 permanent jobs at the site to maintain the project. There is a recreation plan which is required by the Federal Energy Regulatory Commission, who has The recreation plan will cost jurisdiction over the entire project. approximately \$600,000.00. If FERC grants the license it would be for fifty years at which time they plan to renew for another fifty years. The power

plant would be on the West Virginia shore. Mr. Hegemann stated that they are in compliance with all rules and regulations of FERC. The lines follow current Monongahela Power lines (in the plan), but after talking with the engineer, they want to use the railroad right of way and part of Monongahela's routes. Mr. Hegemann stated that they have not made application to FERC for the proposed route, but they are in the process. The law firm of Goodwin and Goodwin will handle the right of way acquisition. A question and answer session followed. A list of those in attendance is attached to these minutes.

On this date, came the City of Parkersburg, by C. Blaine Myers, its Attorney and tendered a Petition for annexation of territory to the City of Parkersburg by minor boundary adjustment. The County Commission set a hearing on said matter for January 31, 1994 at 10:00 A.M. An Order was prepared regarding this matter.

On this date, the County Commission prepared a letter to K.D. Merritt, Sheriff of Wood County in regard to the hiring of Clyde Miles as an employee of the Civil Process Division of the Sheriff's Department. A copy of said letter is attached to these minutes.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and made unanimous by Holmes R. Shaver, entered into a Maintenance Contract by and between JKS Computer Systems and Consulting and the County Commission. The said Maintenance Contract provides maintenance coverage on computer equipment located in the office of the Prosecuting Attorney for Wood County. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of Adjustment Notice No. 1 from the Criminal Justice and Highway Safety Office, Charleston, WV, in regard to the Section 408 Alcohol Incentive Plan Grant No. AI93-05. Receipt of said Adjustment Notice is pursuant to an Order bearing the date of December 9, 1993 at which time the County Commission authorized Holmes R. Shaver, as

President, to sign the letter of request. The said letter requested the reallocation of funds in the amount of \$2,400.00 from the Overtime category to the Equipment category to allow for the purchase of a TV, VCR and stand for the Prosecuting Attorney's Office and VCR Tape Storage Equipment for the Sheriff's Department. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check in the amount of \$835.76 which represents reimbursement to Wood County for expenses incurred during the month of September 1993 in regard to the Comprehensive Community Highway Safety Grant No. 92-HS-14. Receipt of said check is pursuant to an Order bearing the date of November 15, 1993 at which time the Request for Reimbursement was signed by Holmes R. Shaver. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check in the amount of \$248.02 from the State of West Virginia which represents reimbursement to Wood County for expenses incurred during the month of September, 1993 in regard to the Drug Control and System Improvement Grant No. 93-DC-037. Receipt of said check is pursuant to an Order bearing the date of October 21, 1993 at which time the Request for Reimbursement was signed by Holmes R. Shaver. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check in the amount of \$3,624.74 of which \$1,632.00 represents reimbursement to Wood County for expenses incurred during the month of October, 1993 in regard to the Drug Control and System Improvement Grant No. 93-DC-065. The remaining amount of \$1,992.74 represents reimbursement for expenses incurred during October, 1993 in regard to the Drug Control and System Improvement Grant No. 93-DC-037. Two orders were prepared regarding these matters.

On this date, the County Commission approved Personal Property Impropers for Nancy A. Barnhart, Angela Tanner and Service America Corporation.
