Said Executive Session was at the request of Michele Rusen, Prosecuting Attorney and Ricky Woodyard, Investigator.

At 10:00 A.M., the County Commission opened sealed bids for ten

In-Car Mobile Video VHS Recorder Systems pursuant to a Legal Notice appearing in both local newspapers on July 6, 1994 and July 13 1994. Bids were received from Kustom Signals, Inc. - Total \$44,630.00, Options \$3,300.00, Alternate \$40,655.00; and from CMI - Total \$39,500.00, Options \$3,274.00. Upon a motion made by Jean Grapes, seconded by Holmes R. Shaver and passed, the County Commission took the bids under advisement until such time as Tiano-Knopp Associates, Consultants for Wood County, have reviewed the said bids and made their recommendation to the County Commission. An Order was prepared regarding this matter.

At 11:00 A.M., the County Commission met with Charisse Straight from the Humane Society of Parkersburg, Inc. and Robin Weirach from the United States Humane Society. Ms. Weirach stated that they are making progress with the proposed kennel ordinance; they have two representatives for the hobby breeders, two representatives from the dog hunters association, a member of the County Commission, the Humane Officer for the Sheriff's Department and two representatives from the Humane Society working on the said ordinance; she would like to assure the public that regulations are highly needed. Ms. Straight informed the County Commission that Ms. Weirach has been very informative and helpful. Ms. Straight also stated that she will keep the County Commission informed.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Holmes R. Shaver and passed, Ordered that a legal notice be placed in The Parkersburg News and The Parkersburg Sentinel advertising an Auction of County real property to be held on Thursday, September 1, 1994 at 11:00 o'clock A.M. The said real

property being formerly leased to the Family Crisis Intervention Center of Region V, Inc. and being located at 1114 Seventh Street, Parkersburg, WV. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion duly made, seconded and passed, Ordered that the fees for keeping and maintaining prisoners in the Wood County Correctional Center (Jail) for the months of July, August, September, 1994 will be \$45.00 per prisoner per day. It is further Ordered that the appropriate agencies and authorities be notified by forwarding them a copy of the Order that was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Holmes R. Shaver and passed, adopted a Resolution in reference to Budget Revision No. 2 in the Coal Severance Fund budget for the fiscal year 1994/1995. The Request for Revision to the Approved Budget, being submitted to the Department of Tax and Revenue, Charleston, WV, was signed by Holmes R. Shaver, President of the Wood County Commission. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Holmes R. Shaver and passed, adopted a Resolution in reference to Budget Revision No. 1 in the General County Fund budget for the fiscal year 1994/1995. The Request for Revision to the Approved Budget, being submitted to the Department of Tax and Revenue, Charleston, WV, was signed by Holmes R. Shaver, President. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of the Notice of Grant Award Change from the West Virginia Development Office,
