An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Jean Grapes, seconded by Steven A. Grimm and made unanimous by Holmes R. Shaver, appointed Jack L. Buckley to fill the position of Maintenance Superintendent for Wood County. Said position was made vacant due to the resignation of Emmett W. Pickens. An Order was prepared regarding this matter.
