IN RE: MINUTES OF MEETING HELD THURSDAY, MARCH 24, 1994

PRESENT: HOLMES R. SHAVER, PRESIDENT JEAN GRAPES, COMMISSIONER STEVEN A. GRIMM, COMMISSIONER

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission approved an Exoneration for Joseph W. DeHaven - City District. The County Commission also approved Personal Property Impropers for Lyle Freeland - City District; Dee Freeland - City District; Andrew & Cheryl Williams - Vienna District and John G. Schneider Sr. - Vienna District.

On this date, came Michele Rusen, Prosecuting Attorney and presented to the County Commission an Application in which it is requested that the Honorable Gaston Caperton, Governor of West Virginia, issue a requisition on the Governor of Florida for the extradition of Jeffrey Michael Valentine, who stands charged with the crimes of Burglary and Grand Larceny, committed in the County of Wood, West Virginia, in August, 1992, and who is now a fugitive from justice of the State of West Virginia and as the Prosecuting Attorney is informed, is now within the jurisdiction of the State of Florida, in the County of Volusia and the City of Daytona Beach. The said Application was signed by Holmes R. Shaver, President of the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed. An Order was prepared regarding this matter.

Ms. Rusen also presented an Application in which it is requested that

Governor Caperton issue a requisition on the Governor of the State of Ohio

for the extradition of Delmar Leroy Offenberger, who stands charged with the crime

of Grand Larceny, committed in the County of Wood, West Virginia, on January 30, 1994 and who is now a fugitive from justice of the State of West Virginia and, as the Prosecuting Attorney is informed, is now within the jurisdiction of the said State of Ohio, in the County of Washington, and the City of Marietta. The said Application was signed by President Shaver, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of the Approval of the Request for Revision to Approved Budget from the Department of Tax and Revenue, Charleston, WV, in regard to Revision No. 14 in the General County Fund budget for the fiscal year 1993/1994. Receipt of said Approval is pursuant to an Order bearing the date of February 17, 1994 at which time the Request for Revision was signed by President Shaver. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized Holmes R. Shaver, as President, to sign the Request for Reimbursement for the month of February, 1994 in regard to the Drug Control and System Improvement Grant No. 93-DC-065. The Request for Reimbursement is in the amount of \$1,208.00 which represents seventy-five and one half hours devoted to the said Grant by Assistant Prosecuting Attorney, Scott Durig. The allowable expense under the said Grant is \$16.00 per hour. The said Grant has a ten percent matching fund requirement which will be provided through the current annual salary of Assistant Scott Durig. In addition to the Request for Reimbursement, the Monthly Progress Report and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, WV. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Steven A.

Grimm, seconded by Jean Grapes and passed, authorized President Shaver to sign the final Request for Reimbursement in regard to Section 408 - Alcohol Incentive Plan Grant No. AI93-05. The said Request for Reimbursement is in the amount of \$1,464.77 which represents funds expended by the County during the months of December, 1993 and January, 1994. In addition to the Request for Reimbursement, the Progress Report and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, WV. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized President Shaver to sign a letter addressed to the West Virginia Development Office, Charleston, WV, in regard to the Governor's Community Partnership Grant awarded to the County Commission in the amount of \$17,000.00. In previous correspondence, a change of scope for the project had received approval from the West Virginia Development Office to be used toward the purchase of a fire engine for the Lubeck Volunteer Fire Department instead of toward the construction of a building for the Williamstown Emergency Medical Services. Due to the length of elapsed time from the original request by the Lubeck Volunteer Fire Department, which originally had funds committed Farmers' Administration, the said Fire Department entered into a lease/purchase agreement with LaSalle National Bank for the purchase of the requested fire The said signed letter requests an additional change of scope of the said Grant funds to allow the said Grant funds to still be used for the purchase of the said fire engine since a lease/purchase agreement has been entered into. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized President Shaver to sign the Quit-Claim Deed by and between the County Commission and Mary Isabella

Sovel. Said Deed, prepared by Attorney Joseph T. Santer, is pursuant to the Final Order bearing the date of December 6, 1993, at which time the County Commission Ordered that the Southerly Twenty feet of Thirty-Seventh Street (Formerly Jackson Ave.) from Olive Street (Formerly Poplar Street) to Murdoch Avenue, situated in the District of Parkersburg, Wood County, West Virginia, be, and the same is hereby closed and vacated as a street and public way, subject, however, to the restriction that no permanent building shall be constructed on any portion of the said street hereby closed and further subject to such rights of way or easements, if any, to public utilities heretofore created by grant or reservation, over, across or under said unused street. Mary Sovel owns Lot No. 36 of the Wentz and Gangwer's Crystal Springs Addition recorded in Plat Book 1, at Page 38 of which the said Thirty-Seventh Street provides access. An Order was prepared regarding this matter.

On this date, the County Commission Ordered that corrections need to be reflected in the changes Ordered to be made by the County Commission in Property Assessments for the Year 1994 in regard to the Order dated February 28, 1994. A copy of the Order that was prepared regarding this matter, with said changes, is attached to these minutes and should be made a part thereof.

Having no scheduled appointments or further business to attend to, the County Commission adjourned at 12:00 Noon.
