On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission approved an Exoneration for Roger & Cynthia Thompson - Williamstown District.

At 9:45 A.M., the County Commission of Wood County opened sealed bids for the replacement of the roof on the Law Enforcement and Maintenance Building located at 328 Avery Street, Parkersburg, West Virginia. The following bids were received.

opening of said bids is pursuant to an Order appearing in Order Book 56, at Page 51 and bearing the date of August 22, 1994 at which time the County Commission ORDERED that the bid be let, and is further pursuant to a Legal Notice appearing in both The Parkersburg News and The Parkersburg Sentinel in which sealed bids were requested. Upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and

passed, the County Commission of Wood County took the said bids under advisement. An Order was prepared regarding this matter.

At 10:00 A.M., the County Commission met with Attorney Robert K. Tebay, III, representing the City of Parkersburg in regard to the Annexation of Property by Minor Boundary Adjustment, Parkersburg District, Wood County, West Virginia. The County Commission finds that the Petition for said annexation is in proper form and that said property be annexed, by minor boundary adjustment, to the petitioner and accordingly the corporate limits of the City of Parkersburg, be and the same, be changed by virtue of said annexation. A copy of the Order that was prepared, describing the property, is attached to these minutes.

Mr. Tebay then proceeded with a hearing in regard to the Annexation of Property by Minor Boundary Adjustment, Lubeck District, Wood County, West Virginia. The County Commission finds that the Petition for said annexation is in proper form and that said property be annexed, by minor boundary adjustment, to the petitioner and accordingly the corporate limits of the City of Parkersburg, be and the same, be changed by virtue of said annexation. A copy of the Order that was prepared, describing the property, is attached to these minutes.

At 11:00 A.M., the County Commission met with Marlene Martin from Marietta Memorial Hospital. Ms. Martin informed the County commission that medical services are available to the County at Marietta Memorial Hospital.

At 2:00 P.M., the County Commission met with Toni Tiano to

discuss a budget revision in regard to the Community Traffic Safety Program Grant No. 94-HS-07. The County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, authorized Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to sign a letter addressed to the Criminal Justice and Highway Safety Office, Charleston, West Virginia, requesting a budget revision in regard to the Community Traffic Safety Program No. 94-HS-07. The said letter requests that the amount of two thousand three hundred thirty-two dollars and twenty-nine cents (\$2,332.29) be transferred from the Travel/Training category to the Equipment category. Approval of such a request would allow for the purchase of radar units for the Wood County Sheriff's Department, the City of Parkersburg's Police Department and the City of Vienna's Police Department. An abundant supply of radar units for the above-stated Departments is deficient; therefore, the approval for such purchase would enable the said Departments to use the said radar units in conjunction with their traffic safety and speed enforcement programs. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, authorized Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Drug Control and System Improvement Grant No. 94-DC-023. No expenditures were made by the County during the month of August, 1994. In addition to the Request

for Reimbursement, the Monthly Progress Report and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, West Virginia. All documentation pertaining to the said Drug Control and System Improvement Grant is on file in the Office of the County Administrator.

On this date, the County Commission of Wood County was in receipt of the Grant Contract Agreement between the Criminal Justice and Highway Safety Division, Charleston, West Virginia, and the County Commission in regard to the Drug Control and System Improvement Grant No. 94-DC-023. The said Drug Control and System Improvement Grant will allow the continuance of the D.A.R.E. (Drug Abuse Resistance Education) Program by the Wood County Sheriff's Office for an additional twelve (12) month period beginning August 1, 1994 and continuing through July 31, 1995. Funding in the amount of eight thousand seven hundred eighty-three dollars and fifty-one cents (\$8,783.51) approved under the said grant will provide overtime compensation for the existing deputy, assigned by the Sheriff, to carry out the said D.A.R.E. Programs for the County's four (4) elementary schools. Receipt of said fully executed Grant Contract Agreement is pursuant to an Order appearing in Order Book 56, at Page 56 and bearing the date of August 29, 1994 at which time a Resolution was adopted authorizing Holmes R. Shaver, President of the County Commission, to enter in to the said Grant Contract Agreement. An Order was prepared regarding this matter.

At 10:30 A.M., the County Commission met with Kay Williams,

Deputy, County Clerk's Office to discuss a Precinct change. The County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, ORDERED that Precinct 33 be moved to the Beechwood Presbyterian Church, 703 - 30th Street, Parkersburg, West Virginia, due to the closing of Beechwood Grade School, 728 1/2 - 29th Street, Parkersburg, West Virginia. A Legal Notice, prepared by the Clerk of the County Commission of Wood County, reflecting the said change will appear in both The Parkersburg News and The Parkersburg Sentinel on a later date. Placement of said Legal Notice is pursuant to Chapter 3, Article 1, Section 7 of the Code of West Virginia, 1931, as amended. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of the Approval of the Request for Revision to Approved Budget from the Department of Tax and Revenue, Charleston, West Virginia, in regard to Revision No. 1 in the General County Fund budget for the fiscal year 1994/1995. Receipt of said Approval is pursuant to an Order appearing in Order Book 56, at Page 30 and bearing the date of July 28, 1994 at which time the Request for Revision was signed by Holmes R. Shaver, President of the Wood County Commission. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, ORDERED that the amount of four hundred thousand dollars (\$400,000.00) be taken from the Special County Building fund and utilized to purchase a Repurchase Agreement at United National Bank,

Parkersburg, West Virginia. The purchase of the said Repurchase Agreement will earn interest at the rate of 4.70% and is for a twelve (12) month period. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, ORDERED that the amount of three hundred thousand dollars (\$300,000.00) be taken from the Special County Building Fund and utilized to purchase certificates of deposit at Commercial Banking Trust Company, Parkersburg, West Virginia. As reflected in the attached Truth-in-Savings Disclosure, the said County Commission of Wood County purchased certificate of deposit number 5000531662 in the amount of one hundred thousand dollars (\$100,000.00); purchased certificate of deposit number 5000531663 in the amount of one hundred thousand dollars (\$100,000.00) and purchased certificate of deposit number 5000531399 in the amount of one hundred thousand dollars (\$100,000.00). The said certificates of deposit were purchased for twelve (12) month period with the maturity date being September 19, 1995. The interest rate for the said certificates of deposit is 4.70% with an annual percentage yield of 4.78% and interest will be compounded quarterly. The early withdrawal penalty is three months? interest on the amount withdrawn. The said certificates of deposit have been placed in a safety deposit box at the Commercial Banking 👫 Trust Company, Parkersburg, West Virginia. An Order was prepared regarding this matter.

On this date, and pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with

the procedure policy for appointments to board and authorities; the County Commission, upon a motion duly made, seconded and passed, placed Larry Hoffman in nomination for reappointment to the Central Boaz Public Service District Board. Mr. Hoffman's term expires October 1, 1994. Said nomination is further pursuant to an Order bearing the date of September 15, 1994, at which time the vacancy was announced. An Order was prepared regarding this matter.

Having no further scheduled appointments or business to attend to, the County Commission adjourned at 4:00 P.M.

This 19th day of September, 1994, pursuant to the Order entered herein on the 22nd day of August, 1994, th is proceeding came on for hearing before the County Commission of Wood County, West Virginia; and this day came Petitioner, the City of Parkersburg, a municipal corporation, by Robert K. Tebay III, its Assistant City Attorney.

In view of the findings of fact made herein on August 22, 1994, this Commission accordingly concludes that the Petition herein is in proper form; that the area proposed to be annexed is a proper subject for annexation by minor boundary adjustment, and therefore, it is

ORDERED that the following described property, formerly situate in District of Lubeck, Wood County, West Virginia, be, and the same is, hereby annexed, by minor boundary adjustment, to the petitioner herein and, accordingly, the corporate limits of the City of Parkersburg be, and the same are, hereby changed by virtue of such annexation, to include said property described as follows:

Beginning at a point in the existing Corporation Line of the City of Parkersburg, said point being in the dividing line between Lot 36 and Lot 37 of the Otis L. Bradford Estate, as shown in Deed Book 45, Page 243, in the Office of the Clerk of the County Commission of Wood County, West Virginia; Thence, with the said Corporation Line, North 46 degrees, 28 minutes East 654.72 feet to the northeasterly corner of a tract of land described in a deed to James M. Beckett, Jr. and Edna Mae Beckett, husband and wife, dated May 14, 1970, and recorded in Deed Book 574, Page 598, in the Office of the Clerk of the County Commission of Wood County, West Virginia; Thence, with the easterly line of the said parcel, South 46 degrees 48


